



Well, the librarian hubbub concerning Harper Collins' decision to limit libraries' eBook lending to 26 check outs even made it to Billings, Montana, where several hundred librarians were gathered for the Mountain Plains Library Association/Montana Library Association (MPLA/MLA) joint conference that took place last week. At the closing luncheon, during a skyped presentation with author Adriana Trigiani (*Big Stone Gap*), Trigiani, whose books just happen to be published via Harper Collins, quipped: "You're (librarians) the ultimate ball busters of all time. Please forgive them (Harper Collins) – they're fixing it. You've scared the pants off those people." It would seem that a dialogue has at least begun between librarians and Harper Collins. The Connecticut Library Consortium organized a symposium – *eBooks: Collections at the Crossroads*, where Josh Marwell, president of sales for Harper Collins, said to librarians, "We're here because we want to have a dialog with your community. You're very important to us, you've been important to us for a very long time. I don't think our commitment has ever wavered to the library channel." (*Library Journal*, April 5, 2011 – *HarperCollins Executive Calls Circulation Cap a "Work in Progress"* by Michael Kelley)

The 26-loan cap on Library eBooks started March 7<sup>th</sup> and, as Francine Fialkoff, Editor-in-Chief, of *Library Journal* said in the April 1<sup>st</sup>, 2011 issue: "...has provoked the most widespread, vociferous reaction among public librarians to any vendor policy in recent memory..." The reaction has included posting of the *eBook User's Bill of Rights* by Sarah Houghton-Jan, assistant director for the San Rafael Public Library, on her *Librarian in Black* blog (librarianinblack.net). It's also provoked Brett Bonfield, director of the Collingswood Public Library (NJ), and Gabriel Farrell, a library systems developer at Drexel University, to launch a library boycott (boycottharpercollins.com) on buying books or eBooks from Harper Collins until the cap is lifted.





## Young Nebraskans Win Writing Competition

Young Nebraska writers will receive Letters about Literature award certificates from Gov. Dave Heineman on April 13, 2011 at a proclamation-signing ceremony celebrating National Library Week, April 10-18, 2011. Letters about Literature is a national reading and writing promotion program. Just under 70,000 adolescent and young adult readers nationwide in grades 4 through 12 participated in this year's Letters About Literature program—more than 450 of them from Nebraska. The competition encourages young people to read, be inspired and write back to the author who has somehow changed their view of the world or themselves.

This annual contest is sponsored nationally by the Center for the Book in the Library of Congress in partnership with Target Stores. Target sponsors Letters about Literature as part of its national reading initiative, "Ready. Sit. Read!," which is aimed at fostering a love of reading among children at an early age. Since opening its first store in 1962, Target has partnered with nonprofit organizations, guests and team members to help meet community needs. The Center for the Book was established in 1977 as a public-private partnership to use the resources of the

Library of Congress to stimulate public interest in books and reading.

The Nebraska competition is coordinated and sponsored by the Nebraska Center for the Book, Nebraska Library Commission, and Houchen Bindery Ltd. Young Nebraska writers to be honored are:

- **Timarree Speer**, Mason City, to Beatrice Sparks about *Anne's Baby*.

The students wrote personal letters to authors explaining how his or her work changed their view of themselves or the world. They selected authors from any genre, fiction or nonfiction, contemporary or classic. Winners were chosen from three competition levels: upper elementary, middle, and secondary school.

The Nebraska winners will be honored at a luncheon, receive cash prizes and gift certificates to Target Stores, and their winning letters will be placed in the Jane Pope Geske Heritage Room of Nebraska Authors at Bennett Martin Public Library. They will advance to the national competition, with a chance to win a trip to Washington, D.C. for themselves and their parents. Harper Collins decision to limit to 26 loans is intended to line up with the use a print book would see in a year and what they've interpreted as a typical life span with wear and tear of a popular title. HarperCollins also believes that the previous policy of no limits would end up decreasing book sales and royalties paid to authors.

Infopeople provided a webinar on April 11<sup>th</sup> — *Can eBooks Fit into the Print Book Paradigm: Publishers and eBook Lending Limits* – which you can find archived at: <http://infopeople.org/training/webinar/ebooks>. Webinar presenters responded to the following questions:

- Is there true ownership of eBooks for libraries?
- Can libraries exist without ownership of eBooks?
- What is the best access model for eBooks?
- Is there a right of first sale that applies to eBooks?

Now, before we channel all that energy towards HarperCollins – remember that eBooks are not sold outright to libraries but licensed through another vendor, such as OverDrive, who distributes and provides access to library customers. OverDrive has now drawn the ire of Kansas State Library folks. They are crying foul with a recent proposed increase in annual administrative fees that add up to a 694% in just three years. Jo Budler, Kansas State Librarian, and former Nebraskan and Nebraska Library Commission employee, called the OverDrive proposal unreasonable, unsustainable and unacceptable. In fact, she's in the process of preparing a counteroffer to OverDrive. Jim Minges, Executive Director of the Northeast Kansas Library System (NKLS), another former Nebraskan and NLC staff person, advised the libraries in NKLS not to pay for additional content through OverDrive until the issue is resolved, partly

not be renewed. (*Library Journal*, April 6, 2011 – *Kansas State Librarian Goes Eyeball to Eyeball with OverDrive in Contract Talks* by Michael Kelley)

In the meantime, eBooks continue to outsell their print counterparts and the demand for that format will undoubtedly continue to grow. There were multiple sessions at MPLA/MLA on eReaders, eBooks, and iPads, and in my travel to and from Billings multiple fellow travelers of all ages taking advantage of the convenience of reading via a mobile device. So – with deference to Maurice Sendak – “Let the wild rumpus start” or perhaps let the wild rumpus continue – and stay tuned.

Board members should be representative of a) public libraries, b) school libraries and media centers, c) academic libraries, d) special and institutional libraries, or e) users and trustees of such libraries.

The Board governs the Southeast Library System. It is similar to a public library board of trustees or the board of any non-profit organization. Member responsibilities include approval of policies, plans and budget, and selection and evaluation of the System Administrator.

Members serve three-year terms and are eligible for two consecutive terms. The Board usually meets six times a year, at times and places chosen by the members. Members do not receive a salary, wage or fee for their services. Board members must have access to e-mail.

Southeast Library System is a multi-type library network with 248 members offering a wide range of service in public, school, academic, institutional and private libraries (Membership list with populations from 2000 Census are on the SELS web page: [www.selsne.org](http://www.selsne.org).) Membership includes 12 academic institutions, including the University of Nebraska-Lincoln, four private colleges, three community college campuses, a state college and a technical school. Fifty-four public libraries are system members. The majority of these libraries (34) serve populations fewer than 1,000. The system counts 146 school media centers among its members, 54 that are Lincoln Public Schools, with most of those belonging to Class 3 schools (population areas between 1,000 and 100,000). Fourteen of the school media centers are parochial. The system has 28 special and institutional members, most of which are located in Lancaster County.
